For right now, he's cooperative, but he wasn't earlier. It was use of force.

How old is he?

He is twenty [redacted] years old.

[Unintelligible] He's been back and forth there. You probably know him.

Yeah, no, no visible injury right now, except some laceration. He was trying to use a tile to slice his arms and also a little bit of skin tear on the restraints there because he was resisting.
