So I'm trying to see if you guys have an inmate here with this name because the gentleman on the phone couldn't understand anything he was saying, and he wasn't giving a valuable address, other than ending it in 1623, and I'm like, well, that would be our Northwest detention center here. So yeah, call them.

I'm trying to find out if this guy is actually at your facility, and if, because I don't have anything to go on that, I could even put a call for dispatch, because he's not giving any valuable information. If I was to give you a name, would you be able to tell me if this guy is actually inmate? And do we need to talk to somebody about what's going on?
